HEALTH PASSPORT

SMC Health Passport is defined as the minimum standard of pre-clinical requirements that all students and clinical faculty, who plan or potentially may be physically on-site at any of our regional consortium clinical sites, must complete prior to that start of the clinical experience date. This collaborative definition was agreed upon by our consortium Partners to ensure compliance to the highest level of a pre-clinical requirement set across our Clinical Partners sites and aligned with the Oregon Health Authority's Administrative Standard of Clinical Requirements for Student Clinical Training.

For specific immunization vaccination criteria and guidance on the considerations, refer to the clinical affiliation agreement set-up between the clinical facility and the educational program institution.

10-Panel Urine Drug Screen (see addendum)

- Amphetamines (including methamphetamine) (*Required*)

- Opiates (*Required*)

Immunizations

- Hepatitis B (HepB)
- Measles, Mumps, and Rubella (MMR)
- Tetanus, Diphtheria, Pertussis (TDAP)

- Varicella (Chicken Pox)
- Influenza (annual seasonal flu)
- Tuberculosis (TB): 2-Step TB or Quantiferon Gold
- CPR: BLS for Healthcare Providers

CONSIDERATIONS

Clinical requirement official documents for Passport are considered from lab reports, clinical records, employee records, school records, state alert system reports, immunization cards (date, provider's signature, initial or stamps included) or provider letters are acceptable.

Hepatitis B

3 series of vaccines and positive titer or a positive titer (blood test); if the titer is negative or if there is no records, then three vaccinations are required as follows: series #1, series #2 (one month after first), series #3 (five months after second); and these must be followed by a titer (blood test) for Hepatitis B Surface Antibody (four to six weeks after the third shot). Student is allowed to continue with clinical if there is evidence of repeat series#1 and has completed attestation form.

Measles, Mumps, Rubella (MMR)

2 series of vaccines or a positive titer (blood test) for MMR; if the titer is negative, then 2 series of vaccinations are required; the second vaccine in the two series vaccine sequence for MMR is due no earlier than one month after the first one.

Tetanus, Diphtheria, Pertussis (TDAP)

TDAP within the past 10/yr; if a documented TDAP was received after age 19 and more than 10/yr ago, a TD within the past 10/yr will satisfy the requirement; documentation for both the TDAP and TD boosters must be submitted. If there is no documented Pertussis after age 19 and the vaccine was taken more than 10 years ago, TDAP is required.

Varicella (Chicken Pox)

2 series of vaccines or a positive titer (blood test) for VZ; if the titer is negative, then 2 series of vaccinations are required; the second vaccine in the two series vaccine sequence for VZ is due no earlier than one month after the first one.

Influenza (Annual Flu Shot)

The annual seasonal influenza vaccination is valid if received after September 1 for the current influenza season.

Tuberculosis (TB): 2-Step TB or Quantiferon Gold

Students are advised to complete this immunization first as the TB skin testing is affected by other vaccines. 2-Step TB skin test, two separate tests taken 1-3 weeks apart. The IGRA blood test, Quantiferon Gold or T-Spot test may satisfy this clinical requirement. The chest x-ray is an option if either of the aforementioned tests results in positive; an annual TB review of symptoms form is required thereafter.

CPR: BLS for Healthcare Providers

BLS for Healthcare Providers certificate of completion or card from the American Heart Association BLS for Healthcare Providers training
