

## **Student/Faculty Health Screen Requirements**

Each of the following health screen requirements must be met prior to participant beginning his/her educational experience at Piedmont.

## Proof of documentation must be kept on file at the school and available upon request.

- 1. **M.M.R.** (Measles, Mumps, Rubella) Must have *one* of the following:
  - a. Documentation of two doses of MMR vaccine on or after first birthday and separated by at least 28 days
  - b. Laboratory evidence of immunity as evidenced by positive measles titer (measles IgG), positive mumps titer (mumps IgG), and positive rubella titer (Rubella IgG)

## 2. TUBERCULOSIS:

- a. **Evidence of TB testing**: will accept any of the following documentation:
  - i. Negative two-step TB skin test (Step 1 within the last 12 months and Step 2 within the last 90 days from the rotation start date) for all initial student rotations within Piedmont Healthcare.
  - ii. Negative T-Spot or QuantiFERON Gold blood test within the last 12 months from the rotation start date.
  - iii. For history of positive TB test, latent TB infection or TB disease, must have negative chest x-ray at the time of diagnosis or treatment. If student has had TB disease, medical evaluation that student has been treated for TB disease is required.
- b. Must confirm through an electronic questionnaire that they are free of the following symptoms: productive cough lasting more than three weeks, unexplained fatigue, night sweats, unexplained weight loss, unexplained fever, chills or coughing/ spitting up blood.
- 3. VARICELLA (Chicken Pox) Must have one of the following:
  - a. Written documentation of vaccination with two doses of varicella vaccine
  - b. Laboratory evidence of immunity as evidenced by positive Varicella titer (varicella IgG)
- 4. **HEPATITIS B VACCINE:** This vaccine is strongly encouraged for all direct patient care providers or those with risk of exposure to blood-borne pathogens. The following must be on file with the school:
  - a. Documentation of >/= 3 doses of the Hepatitis B vaccine series with documentation of a positive titer drawn after the last dose of vaccine.
  - b. Documented non-responders to the vaccine will be allowed to proceed with clinical rotations.
- 5. **TETANUS/DIPTHERIA/PERTUSSIS:** Documentation of one dose of Tdap within the past ten years is strongly encouraged.
- 6. **COVID-19 Vaccine:** All members of the Piedmont workforce must be fully vaccinated against COVID-19 prior to performing work at or for Piedmont, or they must have a completed declination form in ACEMAPP.
- 7. **FIT-TESTING:** All students who will be entering rooms of patients on airborne precautions should present to the nearest Occupational Health office for fit-testing with an N-95 Respirator mask.

Students/Faculty should notify Manager and Occupational Health if they have been exposed to any known or possible infectious/ contagious condition.
